Children, Incorporated and Nussentials

Children, Incorporated began in 1964 with a simple mission – to assist children in need throughout the world. Although we have evolved as an organization during the last 44 years our mission has been consistent. Our support is simple – we provide support for a child’s basic needs such as food, education, clothing and medicine. It is estimated that we have assisted over 450,000 children to date.

We have been blessed for over four decades with the trust and support of very generous donors as well as by a network of volunteers throughout the world administering our programs for our children. Our success has been enhanced by the fact that we do not reinvent the wheel and we work through organizations already assisting children i.e. day care centers, schools, orphanages, and social centers.

Our assistance is also leveraged through relationships developed with business organizations. Nussentials is an example of a very successful model designed to provide assistance for our children. Their help began with a phone call to Children, Incorporated in December 2006. The main area of discussion revolved around Nussentials’ desire to help feed our children. Subsequent discussions occurred and the program was launched in early 2007.

It is a simple but effective plan – Nussentials donates 5% of their revenue to Children, Incorporated. These donations have resulted in specific feeding programs for our projects in the United States and individual support for children through sponsorship assistance. The sponsorship provides a one on one relationship opportunity between child and sponsor.

Nussentials has been an active supporter and has “walked the talk” – their representatives have visited our project locations and our Headquarters in Richmond; invited Children, Incorporated to address their group meetings and present our mission; and several of their leadership team members participated in hands on shopping with our children for back to school supplies and clothing.

The needs of our children continue to increase, making it ever more important that we continue to find support. We are very grateful for the substantial assistance Nussentials has provided to our children and look forward to the future possibilities as we grow together.
